

An increasingly concerning issue that many financial institutions are experiencing is account takeover fraud. Account takeover fraud occurs when a fraudster gains unauthorized access to your account, often through tactics such as phishing, malware or exploiting weak passwords. Once they have access to your account, they can steal your funds, make unauthorized transactions and potentially compromise your personal information.

Here are some steps you can take to prevent your account from takeover fraud:

- Use strong, unique passwords combining letters, numbers and special characters.
- Be extremely cautious of emails, texts, phone calls or computer pop-ups requesting personal information or urging immediate action.
- Verify the legitimacy of any urgent or suspicious communication by contacting us directly. We will never ask you for your login credentials or to withdraw or transfer funds.
- Regularly check your accounts for any unauthorized transactions or suspicious activity.
- Frequently update your devices such as phones, tablets and laptops to make sure that they are up to date with the latest security patches and antivirus software.

We want to assure you that AgFed is committed to safeguarding your financial information and providing you with the tools and knowledge to protect yourself against fraudulent activities.
